### Criteria

The Lifetime Achievement Award honors individuals with a minimum of 10 years of documented accomplishments in a safety-related field who have had a significant impact on various individuals and organizations. Any individual with more than 10 years of service will be given additional consideration during the selection process.

The impact the nominee has made on the industry may be demonstrated in one or more of the following ways:

- **Programs/Projects:** The individual designed or implemented one or more high-impact programs or projects that have been widely replicated.
- **Products:** The individual has developed influential tools, models, frameworks, or other products used to advance safety and/or save lives.
- **Service/Mentorship:** The individual has contributed substantial time and expertise to help build the safety community (e.g., by leading safety-focused organizations or networks, serving on relevant boards or committees, and/or mentoring others).
- **Presentations & Publications:** The individual has made meaningful contributions to the body of safety knowledge through conference presentations, published articles, books, etc.
- **Scope:** The individual has acted beyond the scope of generally accepted job responsibilities. The individuals' actions have had substantial and far-reaching effects on the safety and welfare of fellow employees and/or the community.
