April is Distracted Driving Awareness Month

Distracted driving is an epidemic on America's roadways. **In 2015, 3,477 people were killed as a result of distracted driving**- that's up 8.8% from 2014, where 3,179 people were killed and an estimated 431,000 were injured in motor vehicle crashes involving a distracted driver. Texting and cell phone use behind the wheel takes your eyes off the road, your hands off the wheel, and your focus off driving – putting yourself and others in danger.

At the Utah Safety Council, our number one priority is keeping you and your family safe. We ask that you no longer tolerate texting or talking on a hand-held phone while operating a company or personal vehicle, or when using a company-issued cell phone while operating a personal vehicle. If you must use your cell phone, please pull over to the side of the road to safely complete your call or text.



Ask anyone who has lost a loved one in a crash and they can tell you, one traffic fatality is one too many. We are committed to eliminating this unnecessary risk and strongly believe that no conversation or text is worth the potential danger.

We encourage you to discuss the dangers of distracted driving with your employees, co-workers, family, friends and neighbors. 
