## Keeping Kids Safe This Halloween

Halloween is a time of year to dress up as our favorite princesses, superheroes, and things beyond our imagination. Parents should take the time to discuss safety tips with their kids to ensure things do not get too scary. According to the National Safety Council, only 1/3 of parents talk to their kids annually about Halloween safety. What's even spookier is that **2x as many child pedestrians are killed while walking on Halloween compared to any other day of the year.**

Here are some great safety tips to review with your kids before they step out the door for a fun-filled night of trick-or-treating.

### Trick-or-Treat Tips:

- A parent or responsible adult should always accompany young children on the neighborhood rounds
- Instruct your children to travel only in familiar, well-lit areas and avoid trick-or-treating alone
- If older children are going alone, agree on a specific time when they should return home
- Teach your children to never enter a stranger's home
- Tell your children not to eat any treats until they return home

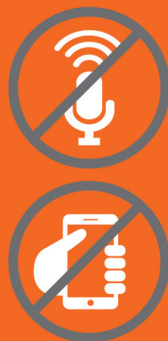
### Costume Safety:

- If children are allowed out after dark, fasten reflective tape to their costumes and bags
- When buying Halloween makeup, make sure it is nontoxic and always test it in a small area first
- Remove all makeup before children go to bed to prevent skin and eye irritation

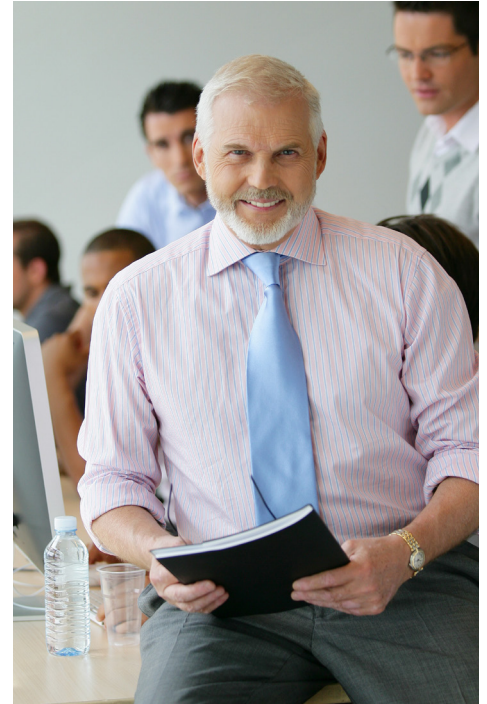
